Time saving support

Medical librarians locate information efficiently, streamlining searches and retrieving essential resources. This allows faculty to focus on other aspects of their careers, such as clinical work, teaching, or research.



Assistance with structured reviews

Medical librarians assist with systematic, scoping, and narrative reviews. Librarians provide guidance on review methodologies, advanced search strategies, and database selection.⁴



Customized instructional support

Medical librarians create customized workshops on topics like evidence-based medicine, literature searching, and advanced research techniques. These sessions help improve research skills and achieve specific teaching and learning outcomes.



Citation management

Citation management tools like EndNote, Mendeley, and Zotero help organize references. Librarians offer training and provide online resources to assist faculty in using these tools.



Resource for point-of-care tools

For clinical faculty, medical librarians facilitate the use of clinical decision-support tools like UpToDate and DynaMed. They also assist in answering real-time patient care questions and help faculty develop case studies for publication.



Access the latest research

Medical librarians help faculty set up database alerts that deliver the latest articles directly to inboxes on a customized schedule.



Finding specialized resources

Medical librarians assist faculty in obtaining hard-to-find materials through interlibrary loan, digital collections, or journal subscriptions.
